President Richard was pleased to see so many in attendance, which represented his first item of business: Do we continue? It is evident by the interest shown that we should continue having an official Belnap Family Organization. He passed out a handout on the Mission Statement of the Belnap Family Organization. In reference to research being done he related to Sir Robert Belknap who Mark Goodmansen has been researching in England. Richard has found that we are related to this man, but not through the Belnap line—through the McBride line. This family is of a Scotch-Irish descent.
