Minutes from March 16, 2010, approved.

Agenda:

1. Joy Belnap reported on the status of the reunion flyers and questionnaires. She mailed 1319 mailers and received about 75 back so far with incorrect addresses. Steven researched correct addresses and mailed many out a second time. Costs for postage was \$580.00 and the flyers cost \$300.00 to print. Wes gave permission to reimburse the mortgage company for the cost of the postage.
2. Pat will compile information on "snail mailed" questionnaires and Wes will compile information on emailed questionnaires.
3. Pat reported that no one has submitted any pioneer recipes. Will the purpose of compiling a recipe booklet be as a handout for a class? or something to sell at the reunion? We are interested in obtaining an accurate recipe for Adalines pickles. Someone suggested that Lois Erickson of Provo has the recipe.
4. Audrey Hobson emailed earlier in the month that Parley Belnap, author of "History of Hooper, Utah – Land of Beautiful Sunsets" may have additional copies of his book to bring to the reunion.
5. Brent Belnap reported the activities of the Dixon family and their Utah itinerary. They will attend the Saturday reunion activities. Graham Dixon has prepared a power point presentation with pictures of St. Mary's church, scenery and landscape in England, genealogy connections, etc. It will take about 30-45 minutes.
Jim Marriott said he would bring a computer/projector and screen for the power point.
