Charter of demise of all lands, rents and services in the town of Westminster which the grantors had by feoffment of Thomas Chaucer, John Golofre, Hamon Belknap and John Warvile, under a condition that if the grantors, their heirs or assigns be impleaded in time to come concerning a tenement in the city of London which they have by gift of the said Thomas, and the same shall without fraud or covin be recovered by his heirs, the heirs of Thomas Pabenham or by any man who has right or title therein by them, their heirs or ancestors, or shall be evicted out of their possession by reason of the dower of Alice wife of Thomas Stonore, or of any recognisance, and they shall be thrust out, it shall be lawful for them, their heirs and assigns, again to enter and hold the tenements in Westminster in their first estate, this demise notwithstanding.
