Order to Roger Manyngford, escheator in the county of Westminster. Somerset,—pursuant to an inquisition made by him shewing that the manors of Clyvedon and Milton and a fourth part of the manor and hundred of Wondestre, co. Somerset, came to the hands of Edward III by the death of Edmund Clyvedon, 'chivaler,' who held by knight service of the heir of Edward le Despenser, a minor in the king's ward, and by reason of the minority of Edmund Hogshaue, son of Thomas Hogshaue, knight, the son of Emmeline daughter of the said Edmund Clyvedon, and kinsman and heir of Edmund, who lately died while a minor in the king's ward, and are still in the king's hand, and that the manor of Clyvedon is held by knight service of the heir of Edward, the other manor and fourth part being held of other lords, and that Joan Hogshaue, whom Thomas Lovell has taken to wife, and Margaret, whom John Bluwet has taken to wife, are sisters and next heirs of the said Edmund Hogshaue, and of full age,-to make a partition of the manor of Clyvedon into two equal parts, and cause the said Thomas and Joan and John and Margaret to have full seisin of the pourparties of Joan and Margaret respectively, as the king has taken the fealties of Thomas and John therefor; and to meddle no further with the other manor and fourth part, delivering any issues thereof taken since the death of Edmund Hogshaue to those to whom they belong.
