

TRIBUTE

A little over a year ago, Carroll York Belknap passed away. This outstanding genealogist had done extensive research into the descendant lines of our immigrant ancestor, Abraham Belknap.

This last July (1977) Dr. W. Dean Belnap and his family visited Margaret Belknap, the widow of Carroll. The purpose of the visit was not only to get acquainted with our distant cousins in Connecticut, but to obtain the excellent repository of records which Carroll had accumulated through many years of research.

Dean brought back with him four file drawers of genealogical material, which he and some of the family members, in particular Della Belnap, are perusing for valuable information on descendant Belknap-Belnap lines in America. Della has corresponded extensively in the past with Carroll Belknap. This will give her and those under her direction an opportunity to update our genealogical records.

Dean left a copy of his book, HERITAGE WITH HONOR, with the Stamford Library in Stamford, Connecticut in memory of Carroll York Belknap, who had made an extensive contribution to the book.







VINSON KNIGHT'S HOME STILL STANDS IN KIRTLAND, OHIO

After several months of research, including a detailed examination of the tax records of Lake County, Ohio, Dr. Keith W. Perkins of the Brigham Young University faculty has confirmed the fact that several buildings and homes which are still standing in Kirtland in the general vicinity of the temple date back to the Kirtland period of LDS Church history. Among them is the home of Vinson Knight, father—in—law of Gilbert Belnap. It is a short distance from the temple at the intersection of Joseph and Cowdery Streets. A plaque has been placed on the home indicating that it has been designated as a "Heritage Home" by the Lake County Historical Society.

Dr. Perkins' findings were presented by him at the annual meeting of the Mormon History Association, which was held April 22-24, 1977, in Kirtland. It was a thrilling experience for my wife, Pat, and me to hear this presentation and to attend the various meetings of the convention. Three of the meetings were held in the temple itself. As we sat in this beautiful building on Sunday morning, April 24, 1977, the hymns which were sung by the Saints at the dedication in 1836 were played by a musical ensemble. A part of the dedicatory prayer was read, as was Section 110 of the Doctrine and Covenants. It enabled us to more fully appreciate the feelings which must have been experienced by Vinson and his wife, Martha, as they worshipped there a hundred and forty years ago.

The temple played an important role in Vinson's life during the time they lived in Kirtland. It was there that he attended many glorious meetings in the company of the Prophet Joseph Smith and the other Church leaders. It was there that he received his annointing by Joseph Smith, Sr., the Church Patriarch, and in turn had the opportunity to annoint and bless others.

As we consider the blessings which we now enjoy, let us express our thanks and appreciation for our ancestors who provided such a great heritage for us. Let us renew our determination to serve our Heavenly Father by doing our part in the BELNAP FAMILY ORGANIZATION to the best of our ability.

Mabel and myself having been to the timber the day before for a load of wood decided to saw it up in furnace lengths, so we went to work with our tractor operated saw down by our shop. Shortly after Max Mortensen came up to our place telling us that the Teton Dam broke and was coming fast, get out fast.

So we tried to get our house in order for what was to come, staying as long as we dared, moving some things upstairs. We loaded some things in the car and pickup and headed for the Parker Hill where we with a lot of others watched and waited for what was to come. Some of the dust and things ahead of the water we could see and some of the water running over the hills. After some time of waiting and watching we eventually all ventured down across the Snake River to see what was happening. Mabel and I being the last to go leaving our car there. We saw the water as it came around Austin Price's place, crossed the road to Ray Price's and crossed the road north of Ray's house to the west.

We followed some cars up east to Spence Harris's place were they didn't get any water. We turned south down to William's place that was about as far as we could get at that time. We turned to the Harris place, then on down the hill west to the gravel pit road, down it to about half of a mile north of our home. I put on my boots, left Mabel in the pickup and walked down thru Howard Clark's field when just across the road from our place I found no bottom going under the water, the second time I came to the surface I said to myself, "I guess if they ever find you it will be in this mess." The water was mighty cold. Each time as I came to the surface I got all the air in me I could and held my breath as I went under again. I managed somehow to get one boot off with some unseen help. I guess I hadn't finished my stay and work on this earth.

About the seventh time I came to the surface I caught the bridge abutment. I was so cold and tired it was all I could do to hold on until I regained strength enough to crawl on top into the house. I found some dry clothes upstairs, a pair of shoes and a cap, and started back to Mabel and the car. I took a flash light and a small pole about six feet long to hold to in case I got in deep water. It was a safe return. We stayed with Spence Harris that night safe and sound. After getting lost in the dark in Ted Mortensen's field. Two days later I found my hat hanging on a stick in the water hole as if it were a marker. This is the place.

THE MYSTERY OF JAMES DARE BELKNAP

Debates in Congress, slavery trouble in Missouri, bleeding Kansas, The Homestead Act, discovery of gold in California all had their effect on people living on the Eastern Seaboard. One person of interest and of importance to me was James Dare Belknap.

Then, the blazing of a trail by Daniel Boone opened the way for thousands of people to trek westward. Almost overnight Kentucky became a State, likewise Kansas.

The Homestead Act passed by Congress deeded one hundred sixty acres of land to any family who would build a home and farm the land. Families from the North rushed to keep Kansas free. Much strife and bloodshed in the area rightfully named it Bleeding Kansas.

The discovery of gold in California gave impetus to people to go farther West. One family from Pennsylvania, the Rhoads, made their way to Kansas. James Dare Belknap, married to Rachel Rhoads, a daughter, might have come that far with them.

In 1850, after four years of preparation, James Dare Belknap, restless and with a roving nature, loaded his conestoga wagon with all his earthly possessions to join a company going West. Taking his wife and two daughters, Elizabeth and Mary Ellen, he turned his face westward to face the unknown.

The trip was slow, long, and tiresome. Frequent stops were made for the oxen to eat and rest. The company had one skirmish with Indians, where one girl was lost in the fight.

After coming through South Pass in Wyoming, it is not known whether they went by Fort Hall or Fort Bridger and Salt Lake City. However, the roads came together on Raft River near the Utah-Idaho border then headed West through the City of Rocks, up the Goose Creek Valley to the Humboldt River, Southwest across Nevada to where Carson City is, then over the Sierra Mountains to California, San Jose, where their journey ended.

Here they rested while James Dare Belknap tried to find work. Not succeeding, he moved his wife and two girls to Mokelumne Hill, where he went to work for a mining company. His job was to furnish supplies for the company. On one of his trips he was caught in a severe snow storm and blizzard. Not being able to see the narrow road, he went over the cliff. The wagon and the dead horses were found the following Spring, but the body of James Dare Belknap was never found.

I have never been able to establish that branch of the family to which he belongs. His mother-in-law, Barbara Rhoads, lived in Kansas, died there at the age of 104. His wife, Rachel, lived to the ripe old age of 93.

Mr. Charles K. Bailey married Mary Ellen, daughter. Mr. Bailey was an outstanding frontiersman of California.

Any information giving the genealogy of James Dare Belknap and Rachel Rhoads Belknap will be gratefully appreciated.

Cystic Fibrosis Victim Earns Eagle Scout Badge

Attaining the rank of Eagle Scout is a special moment in any boy's life. But for 14-year-old Lee Belnap, 1312 Tetonia Drive, who is to receive his Eagle Scout badge tonight, the moment will be an extra special

Lee's struggle to earn the rank was complicated by the fact that he has cystic fibrosis - a disease that attacks the lungs and makes breathing difficult.

Belnap decided to tackle the Eagle badge quest when he read that another boy with cystic fibrosis had become the first person with the disease to achieve Eagle Scout.

Many of Belnap's badge-earning projects centered around cystic fibrosis. His main project consisted of putting out 100 donation cans during Cystic Fibrosis Month in stores throughout Boise last September.

He organized eight Scouts on the project and raised more than \$200 - as much as was collected through the other CF drives in Boise that month and about the same amount collected in Boise during all of 1976.

He also addressed envelopes for the CF Foundation and designed a cover for the Cystic Fibrosis Regional XV Conference in 1975. The folder, which showed a boy in a hospital bed on one side and a boy playing football on the other side, cited "Two Decades of Progress."

It also exemplified Belnap's own progress concerning his handicap since he became a Scout.

"Scouts helped me grow in many different areas," he said. "But they were the real turning point in helping me learn to accept letting others know I had cystic fibrosis."

Belnap was referring to his two daily one- or two-hour treatments that require him to place a mask over his face to dilute the mucus that clogs his lungs. When he went on a hike, he could miss one treatment, but couldn't miss both treatments if he went on a camping expedition.

"I was afraid the kids would think I was wierd if they saw me taking my treatments." Belnan said. "But I finally decided to go ahead and go to camp, and none of the kids stared at all. CONSTITUTION AND BY-LAWS

of the

BELNAP FAMILY ORGANIZATION

1977

ARTICLE I

The name of this Organization shall be "BELNAP FAMILY ORGANIZATION."

ARTICLE II

THE PURPOSE AND OBJECTIVE FOR WHICH THIS ORGANIZATION HAS BEEN ESTABLISHED IS TO STRENGTHEN THE TIES OF FELLOWSHIP AND KINSHIP BETWEEN LIVING MEMBERS OF THIS FAMILY. TO PERPETUATE THE NAMES AND ACHIEVEMENTS OF THE MEN AND WOMEN WHO BEAR THE NAME OF BELNAP AND CREATE A SPIRIT OF FELLOWSHIP AMONG THEIR POSTERITY.

This, in part, shall be accomplished in the following manner:

- 1. Preserving old landmarks, collecting relics, establishing a library of historical and genealogical matter, securing unprinted manuscripts, and photographs.
- 2. Unifying all genealogical, historical and biographical research necessary. attendant to the compiling of an acceptable family record.
- 3. Performing the necessary temple ordinances in behalf of all deceased ancestors of this Family.
- 4. Combining the resources and efforts of the members of this Family so that the history and genealogy of this Family may be passed on to all descendants.
- 5. Promoting Family unity through a bi-annual general Family Reunion.
- 6. Annual reunions following the children lines of Gilbert Belnap.
- 7. Publishing annually a Belnap Family CRIER to provide historical achievements and accomplishments of Family members.

ARTICLE III

Any person may be eligible for membership in this Family Organization who is a descendant of Gilbert Belnap, or the husband, wife or children of any of these descendants, or any direct descendant of other families bearing the Belnap name or any derived spelling of this name.

Eligible persons may become members of this Organization by presenting a pedigree chart and family group sheet to the Secretary of this Organization.

ARTICLE IV

Members of each of the following families who are children of Gilbert Belnap (Gilbert R., Reuben, Joseph, Martha Jane, Hyrum, Augustus, Vinson, Amasa, Mary, Adaline, Lola, William, Oliver, Francis and Isadora) shall organize individual family organizations and appoint one member to serve on the Board of Directors of the Belnap Family Organization for a period of two years.

ARTICLE V

The officers of this Organization shall consist of a President, three or more Vice Presidents, Secretary, Treasurer, Historian, Family Genealogist and Belnap Family CRIER Editor. The offices of President and Vice Presidents shall be elected at the bi-annual reunion of the Organization, and their term of office shall begin as outlined in the By-Laws. All officers shall be eligible for re-election or reappointment as outlined in the By-Laws. The offices of Secretary and/or Treasurer, Family Historian, Genealogist and Editor of the CRIER shall be appointed by the President and Vice Presidents, but should not be changed frequently unless such action is justified. The officers of the Organization shall appoint members to fill these positions as necessary.

ARTICLE VI

The President, Vice Presidents, Secretary, Treasurer and Immediate Past President shall constitute the Executive Officers and it shall be their duty as a committee to represent the Organization to carry out the purposes and objectives of this Organization, appoint committees and perform such other work as may be delegated to them by the Organization. To publish books, print pictures, publish records as they deem necessary, to publish and distribute an annual Family CRIER to all members of the Organization.

The Officers (executive and appointed) shall meet at least three times during the year and be diligent in the duties of fulfilling the purpose and objectives for which this Organization was established.

ARTICLE VII

All records, books, photographs, supplies, etc., purchased, donated or accumulated by the Belnap Family Organization shall become the property of said Organization. Inventory of all items and records shall be properly marked, indexed and maintained.

ARTICLE VIII

The Executive Officers shall have the authority to appoint an Executive Secretary and to set a monitary compensation for said Executive Secretary.

ARTICLE IX

The Executive Officers shall have the authority to enlarge upon the necessary committees as may become necessary from time to time as the Organization grows or as it becomes advisable to conform to the suggested organization as set forth by the LDS Church.

ARTICLE X

The Executive Officers of the Belnap Family Organization are herewith empowered to set membership fees or other assessments as deemed necessary for the expenses and continuation of the Organization.

ARTICLE XI

The children of members may join the Belnap Family Youth Organization established for those 21 years of age or younger.

ARTICLE XII

The By-Laws and Charter of the Belnap Family Youth Organization shall determine its organization, purpose and objectives.

ARTICLE XIII

The Articles and subsequent Amendments of the Constitution of this Organization may be amended by a majority vote present at the bi-annual reunion. Amendments and changes will be printed and made available to the Family members prior to voting at the bi-annual general Family Reunion.

SECTION I: The Board of Directors shall meet annually at a time and place so designated by the President of the Family Orgnization. They shall hear and approve the President's annual report and the financial report of the Treasurer. Each member of the Board of Directors shall be responsible for his immediate family organization to see that correct names and addresses, research, historical, genealogical information and changes in each family by birth, marriage and death is reported and sent to the Secretary.

SECTION II: The President shall be responsible for all the achievements and activities of the Belnap Family Organization. He shall preside over and conduct all meetings of said Organization.

SECTION III: All meetings of the Officers (executive and appointed) and Board of Directors shall be subject to the call of the President. Any three Directors may call a meeting by giving written notice to the Secretary thirty (30) days before said meeting shall convene. The Secretary shall notify all officers and directors of said meeting.

SECTION IV: The First Vice President shall assist the President as needed and shall serve as Chairperson of the Research and Genealogical Committee.

SECTION V: The Executive Officers shall appoint a Research and Genealogical Committee to consist of the Family Genealogist and others to serve as the Officers shall deem necessary, but in no event less than four members. The First Vice President shall call and preside over all committee meetings. This committee shall be responsible for the following:

See that the Family research is being done and encourage all members to participate.

Coordinate all research and temple work and assign lines of research where needed.

See that we are receiving information from the Family lines on research.

See that the information received is being distributed and the Family is being informed as to what research and who is doing the research.

See that the information received is being recorded in a permanent record and that information for the members is being compiled and published.

SECTION VI: The Second Vice President shall assist the President as needed and shall be directly responsible for the following activities:

Contact each Family Representative and have dates of all reunions for the coming year.

Coordinate all Family Reunions so we don't have conflicting dates and places.

Work with each Family for their cooperation and assistance for the bi-annual Belnap Family General Reunion.

Plan the bi-annual family reunion, take charge of the program, activities, and handle all publicity connected with same.

Encourage families to hold reunions.

Organize committees to help when needed and serve as chairperson.

SECTION VII: The Third Vice President shall assist the President as needed and shall be directly reponsible for the following activities:

Work with each family organization to see that they are fully organized, including the youth organization.

Keep the families informed as to all activities of the Belnap Family Organization.

Assist in encouraging that research work, and changes in the membership are reported to the Secretary or Research and Genealogical Committee.

Encourage the family organizations to become active in accomplishing the purpose and goals for which this Organization was established.

Organize committees to help when needed and serve as Chair-person.

SECTION VIII: The Third Vice President shall notify each Family Representative when temple work is done. Said information is to be received from the Research and Genealogical Committee.

SECTION IX: The Secretary shall maintain accurate and up-to-date addresses of all members of the Belnap Family Organization, maintain the minutes of all meetings of the Officers and reunions, maintain a record of all temple work being performed and research accomplished (numbers only), shall mail information, letters, announcements, notices, etc.

SECTION X: The Treasurer shall keep an accounting of all funds received and disbursed, handle the collection of funds from the individual members and family organizations, and shall make an accounting to the Executive Officers annually.

SECTION XI: The Historian will gather historical information from all members of the Belnap Family Organization. This information shall consist of accomplishments, deaths, births, marriages, achievements, newspaper articles, photographs, etc. Information will be maintained in a binder and turned over to the Family Officers annually.

SECTION XII: It is the duty of the Family Genealogist to receive all genealogical information, correspondence and information from researchers, the family and the research libraries. The Family Genealogist will be the Family Representative for LDS Temple and pedigree information. Name and address of Family Representative to be on record at LDS offices. Shall serve as the Vice Chairperson of the Research and Genealogical Committee.

SECTION XIII: It is the duty of the Editor of the Belnap Family CRIER to publish an annual publication providing the Family with historical information, statistical changes in the families, genealogical information as it becomes available to the family at large, reunion notices and other items of information to strengthen, build unity and harmony in the Family Organization.

SECTION XIV: All expenses incurred by the Family Officers in the publishing of the Belnap Family CRIER, genealogical research and all other expenses will be approved by a majority vote of the Executive Officers.

SECTION XV: The Executive Officers shall constitute the nominating committee for selection of candidates to be placed on the ballot at the bi-annual reunion and obtain the consent of each nominee.

SECTION XVI: The President of the Belnap Family Organization shall not remain in office for more than one term at a time; but may become a candidate for election to succeed himself, but not for more than three successive terms.

SECTION XVII: The incumbents First, Second and Third Vice Presidents and President shall be the only eligible candidates for office of president of the Belnap Family Organization. The incumbent vice presidents may be candidates to succeed themselves as vice presidents but not for more than three successive terms.

SECTION XVIII: It is advised that the Secretary not be permitted to remain in office for more than five terms.

SECTION XIX: The nominating committee shall recommend one or more names for the offices of President, First, Second and Third Vice Presidents. These names so recommended by the nominating committee shall be printed on a ballot in alphabetical order for the office so designated. Balloting for the family officers shall be conducted at the bi-annual reunion during one of the regular conducted meetings. Balloting shall be in secret and the ballots turned over to the President and Secretary for tabulating. Results of the election shall be given and the new officers shall be installed at the close of the final meeting of the reunion.

SECTION XX: Balloting for officers of the Belnap Family Youth Organization will be conducted as outlined in their constitution and by-laws at one of their regular conducted meetings of the reunion.

SECTION XXI: Only those 16 years of age or older are elibible to vote for officers of the Belnap Family Organization.

SECTION XXII: The newly-elected officers of the Belnap Family Organization shall take office when installed and are required to meet no later than 30 days from the date they are elected. Other officers of the Family Organization, as outlined in the By-Laws and committees, should be appointed within 30 days after the new officers are elected.

SECTION XXIII: In the event of the death or resignation of an officer, the Executive Officers shall appoint a new officer to fill the unexpired term.

SECTION XXIV: It is the duty of each family to appoint a Family Representative and so notify the Secretary. Each family will appoint a new Family Representative upon the death, illness or resignation and so notify the Secretary.

SECTION XXV: The President shall appoint as many committees as necessary to fulfill the assignments set forth in the preceding By-Laws.

SECTION XXVI: The By-Laws of the Belnap Family Organization may be amended, altered or added to by a majority vote of the members voting at the bi-annual reunion. Amendments and alterations will be printed and made available to the family members prior to the voting at the bi-annual general family reunion.
