



Nothing is known regarding Samuel² or Nathaniel², and it is presumed they died young, possibly killed during some Indian war.

6. DOROTHY2 HENDRICK, dau. of Daniel and Dorothy (Pike) Hendrick, was born May 31, 1659, in Haverhill, Mass., where she died Jan. 9, 1701-2, m. Aug. 28, 1684, in Haverhill, Mass., Ephraim Roberts, b. about 1650, in Ipswich, Mass., d. before July 10, 1738, when his will was proved. When Dorothy died, she left seven children, the youngest less than a year old, which left her husband in sore straits. Hannah Howe, the widow of John Howe, having leased her farm in Ipswich, Mass., came to Haverhill, probably to live with her father, Nathaniel Brown, and it was here she was courted by the widower, Ephraim Roberts. In the old Norfolk County records are the following: "Jan. 10, 1702-3, Ephraim Roberts of Haverhill, Mass., widower, was married to Hannah Howe of Haverhill, widow, per me, Robert Pike, and he declaired that he did renounce meddling with her estate." She had children by her first marriage, and two by this second marriage. After Ephraim Roberts' death, she removed to Methuen, which was set off from Haverhill, where she lived with her son, Dea. James Howe, and her daughter, Martha, who was unmarried, and is mentioned in her will as "helpful to me in my old age and sickness." Her will was dated Mar. 22, 1744-5, and proved May 13, 1745. Daniel Hendrick, Mar. 13, 1692-3, gave them a deed "for that good will which I bear to my natural daughter, Dorothy, now ye wife of Ephraim Roberts, and my son-in-law, Ephraim Roberts," and confirmed to them "five acres of land in Haverhill, called ox comon land, which ye said Ephraim had in his possion seven years agoe." And on the same date he gave them a

deed as follows: "for £20 unto my son-in-law, Ephraim Roberts," land in the third division besides, "ve Town Brooke of Haverhill, by Old Spicutt path, so called, together with a piece of (blurred) meadow, by estimation twelve acres," Essex County deeds, Book 10, pages 124-125. Ephraim Roberts is said to have been a cooper by trade. They lived in Haverhill, Mass., where he bore a modest part in the affairs of the town. At the town meeting, Mar. 22, 1692-3, he was chosen Fence-viewer, with his brother-in-law, Israel Hendrick "to view the town between the mill brook and Great Plains." Again Mar. 1, 1694-5, he was chosen to the same office "for the Great Plains and Eastward." In Dec., 1698, "Ephraim Roberds" was one of the 34 subscribers for "setting up the new meeting house, as soon as the glass windows are finished and set up." Mar. 7, 1698-9 he was chosen surveyor of highways. Mar. 4, 1700-1 he was elected one of the selectmen, and again Mar. 7, 1709-10. With the rank of sergeant, he "led seven sentinals from the Haverhill garrison" in Mar. 1706-7. It is very probable that he was the Ephraim Roberts who was a member of the "Snow Shoe" company. The Governor had authorized this company to be equipped with snow shoes, that they might the better, be able to travel in the winter, over the snow, in the pursuit of the Indian Marauders when necessity required it. He was very sick in 1732, and made his will, dated Oct. 27, 1732, but recovered, and strange to say, although this will was not probated, it is on file in the Probate office in Salem, Mass. He made a second will, dated Feb. 3, 1736-7, and this will was probated July 10, 1738, and is as follows:

In The Name of God, Amen. February the third Day anno Domi 1736-7, I Ephraim Roberds of Haverbill and County of Essex and provence of the Massachusetts Bay in New England,

Yoman, Being Vearey weeak and infirm In Body but of perfect mind and memory Thanks be given unto God; Therefore Calling unto mind The mortality of my Body and Knowing that it is appoynted for all men once to Dye Do macke and ordain this my Last will and Testament that is to Say principly and first of all I give and Reccomend my Soul into the Hands of God that gave it, and my Body I Recomend to the Earth to be burried in Decent Christian Burrial at the Discression of my Executor, Nothing Doubting but at the general Resurrection I shall Receive the Same again by the mighty power of God, and a Touching Such Worldly Estate wherewith it hath pleased God to bless me In this Life I give Demise and Dispose of the Same in the following manner and form:

Imprimis-I give and Bequeath to Hannah, my Dearly Beloved wife Dureing the time She Remains my Widow The free use of The one Half of my now Dwelling House from the Bottom of the Cellar to the Top of the House. I also give her The use of one Horse fit for Her to Ride on and Likewise The use of two Cows and ten Sheep, I also give my wife Two Swine, I also give her The improvements of two thirds of the Housel Stuf & Household goods and it is my will and pleasure that upon my Decease all my Housel Stuf and Household goods Shall be prised, and the one Third I give to my well beloved Daughter Hannah Putnam at Salem and the two Thirds that Remains that my wife shall have the improvement of and at her marrage Day or at her Decease it shall be Equally Divided and my well beloved Daughter patience I give the one Half and my well beloved Daughter mary I give the other, And it is allso my will and pleasure That at my wives marriage or at her Decease the Horse and two cows and ten Sheep that my wife hath had, the improvements of shall be Returned to my Executor.

Secondly, I give and Bequeath to my Beloved Son Samell's two children namely Samuel Roberds and many Belknap the Sum of Thirty pounds Twenty pounds to my grandson Samuel Roberds to be paid to Him when he shall arive to the age of twenty and one year, and to my grand Daughter many Belknap the sum of Ten pounds at or Before two full years after my Decese Those sums are to be paid by my executor.

Thirdly, I give and Bequeath to my Beloved Son Ephraim's children the Sum of Thirty pounds in money (viz.) ten pounds

to my grandson David Roberds when he shall arrive to the age of twenty and one years and twenty pounds to his four Daughters to be Equally Divided among them at or Before two full years after my Decese those Sums to be paid by my Executor.

fourthly I give and Bequeath unto my Beloved Son Jonathan all my Land That was my Son David's and allso all my Land Lying on the East Side of the way by my Dwelling House and allso twelve acers of pasture Land which I Bought of Mr. James Peeker and allso all my personal and Real Estate which I have not all Ready Disposed of in this my Last will and testament or shall not Dispose of herein And it is my will and pleasure That my son Jonathan Shall pay to such persons those Sums that hath been mentioned, and shall be mentioned he being allso to be my Executor.

fifthly, I give and bequeath to my Beloved son Daniel all my Homestead Lying on the west Side of the Road by my House together with the Buildings Excepting the one Half of the House, The improvements whereof I have given to my wife During her Widowhood and at her marriage or Decese it shall be his, and it is my will and pleasure that my Son Daniel Shall boy to my Executor namely to my Son Jonathan the Sum of Sixty pounds at or Before one half year after my Decese.

Sixthly I give and Bequeath to my grandson David Felton of Salem the sum of fifteen pounds to be paid by my Executor at or Before two full years after my Decese.

Seventhly, I give and Bequeath to my grandaughters Ann and Sarah the Daughters of my Beloved Son David the Sum of Thirty pounds, fifteen pounds apence to be paid at or Before two full years after my Decese or at their marriage Day, to be oaid by my Executor.

Eightly, I give and Bequeath to John Atwood whom I have Brought up from a child as a Reward for his obedience while he was with me, the Sum of ten pounds at or Before Three full years from my Decese to be paid by my Executor.

Ninthly I give and Bequeath to my grandson David Roberds the Sum of twenty pounds to be paid by my Executor when he shall arise to the age of twenty and one years.

Tenthly, I give and Bequeath to Marah Staples whom I brought up the sum of five pounds to be paid by my Executor

when she Shall arive to the age of Eighteen years provided She Shall Live and be faithful and Serve me or my wife untill She arive to the age of Eighteen years.

Lastly it is my will and pleasure and I ordain That all those just Debts which in Duty right or Concience I owe To any person or persons whatsoever together with my funeral Expenses & Charges be well and truly paid by my Said Son Jonathan in convenient Season after my Decese whom I Likewise constitute mack and ordain my Sole Executor of this my Last will and Testament and I do hereby utterly Disalow Revock and Disanul all and Every other former Testaments wills Legacies and Bequests and Executors by me in any ways before named willed and bequeathed, Ratifiying and confirming this and no other to be my Last will and Testament, In witness whereof I have hereunto Set my Hand and Seal the Day and year above written.
