Sat. 8 - Nothing of notice  
occurred till afternoon  
then we had a nice  
time at Bro. W. for the  
purpose of inst. & church  
& ordained Bro. C. N.  
Casbit to N. before the hood  
& laid laws & covenants  
before them.

Sund 9th I rec'd a  
nice at same place & Bro  
L. spk to the people & bare  
testimony that his spirits  
were clear from their  
blood for they had much

preaching & then Bro:  
F. Love test to them &  
gave an exhortation &  
then I did know a bare  
test in the gift of tongues  
& 4 came forward to be  
baptized & Bro. L. waited  
upon them & the spirit  
of the Lord their names  
were as follows Levi  
Mackerson Emery Barrows  
Mrs. Nichols Patsy & Brown  
then came together again  
& I confirmed them then
