Pressures Too Much, Mart Slips

NEW YORK (AP)—The stock market, bowing to what analysts said was profit-taking pressure, turned sharply downward today after nine straight sessions of advance. Trading was heavy.

At noon the Dow Jones average of 30 industrials was behind 8.63 points at 858.16. Declining issues on the New York Stock Exchange led advances by 5 to 2.

Turnover on the Big Board was running at approximately the same pace as on Tuesday. Within 21.38 million shares were traded—the second-highest volume in exchange history. Brisk trading caused the Big Board tape to run a minute behind.
