This is the last will and ordinarie of me Henry Kekelnap Esquire made the
day of Juny the year of our Lord god in the first year of the Kingdome of
Henry the sixth the said Henry then being in good and hale mynde And be thence
I will and ordinarie that myn executor shall well and truly see my dettye be payd
the discharge of myn p[er] and of the p[er] that I stand charged for as they will answer
before god Also I will and ordinarie that myn executor shall receive of myn Manors Landys and
tenementys in the Countie of Warwyke yearly for the terme of viij year next to the contentacion of
my said dettye and the residue of the same viij to be after my dettye be payd toward the mar-
riage of my daughter And if so be that myn executor be troubled lett and put from the
receyve of the said viij so that they may not pay my dettye therein Then I will that myn
executor shall asureth wode in myn maner of Knelt as shall suffice to the contentacion of
my said dettye so that in no wyse the contentacion of my dettye be vnder for lack thereof
And than the said viij to be a assureth thereof it may be leved and receyved shall go toward the
marriage of my daughter Also I will that immediately after my decess Margarete
my wyfe shall have the Maner of Knelt w[ith] th[er] appurtenances in the Countie of Suff[er] and
all the Landys and tenementys w[ith] and p[er] that I have in Kettleby and p[er] in
the same Countie for terme of hys lyfe And I will that she shall have full and sell my
wodeys or tymbre greynys in the said Maner or Landys as long as she is she remaund
so that my dettye be payd to the wyf to be payd of my maner Landys and tenementys
in the same Countie of Warwyke as is before w[ri]tten And if that she hereafter marry then
I will that she shall have yearly for terme of hys lyfe wodeys in the same Maner and Landys
to make of it as she best And if that the said wyf shall have an dymall rent of
maner by the year out of all my Landys Maner Landys and tenementys that I have
in the Countie of Warwyke as a sufficient claufe of distresse as may be for hys p[er] for
for terme of hys lyfe in recompens and in the name of all hys dettyes of all the maner
Landys and tenementys that I have in the said Countie of Warwyke except the Landys
assignyd for the Juynture of my daughter in Lawe And if Margarete my wyfe decess
my sonne Edward or he that shall have to be myn heire being then the age of xij year then
I will that myn executor p[er] the issue receyved and profites thereof till my sonne Edward
or he that shall be myn heire come to the age of xxij year to the sustentacion and mar-
riage of my daughter then being unmarried but if that my sonne Edward or he that shall
shall be myn heire w[ith] take the charge of the fundys and marryage of my said daughter
And if he will so do then I will that he have the said Maner and Landys immediately
after the decess of my said wyfe Also I will after the decess of my said wyfe
that w[ith] my sonne shall have an dymall rent of p[er] maner by the year out of the
Maner of Knelt as a sufficient claufe of distresse for terme of hys lyfe And I
make and ordinarie Margarete my wyfe John Kekelnap and Robert Wotton myn executoros
to execute and p[er] that my will in every thing according to myn content as they will
be done for in case lyke p[er] the day and year above w[ri]tten Also I will that
if my said wyfe be married before that my daughter be married or be fore that the
marriage of the marriage be content and paid and that my dettye be payd to the said
wyf as is before w[ri]tten Then I will that myn executor shall yearly make in the
said Maner of Knelt and Landys as of belet to the contentacion of the said
maner during the lyfe of my said wyfe if the said maner be no other content

tenementes rentes and pnces that I have in the Realme of England pteff I will that dno
my wyf hve my lordys and tenementes rentes and pnces that I have in the pssh of
Fride and Wymore for the tyme of hys lyf to hys wif and hys children p that she kepe
hys armours and kepe contynual residence and household in my principall place at the fere
in the pss of Fride durynge all the pss of hys lyf and that she kepe hys dower
of all my other lordys and of the lordys and tenementes that she and I have jointly in the
shire of Essex after the decease of Robert Lytelord hys brother and if it sh be that my
wyf mary a hys not contynual household in my pss place as it before wher as legyn
hys dower of any of my other lordys or tenementes than I will that she shall have a summe
of pte by yee going out of all the pss lordys and tenementes for tyme of hys lyf in the name
of pte for all the that wyf shal have to hys of and for jointe dower or my other wif that
she shall have of all my lordys and tenementes wher sover they be and after the decease of my
wyf or when that she shall have the pss wif and in name and for all my lordys
and tenementes as it before wher sover I will that Thome my sone have all my pss lord
and tenementes rentes and pnces to hym and to hys heires forever Also I will that dno my sone
shall have after the decease of my wyf and hys brother Robert Lytelord a place in Southwarke
called the white horse w the chappell thert adjoynng to hym and to dno hys wif and to the
heires males of hys body lawfully begoton and for default of such issue it shall remaine to my
other sones in name and pnce as it before wher sover Also I will that Edward my sone shall
have after the decease of my wyf and hys pss brother lordys and tenementes in Southwarke
to the ptech value of pte by yee a howe all thys to hym and to hys heires males of hys
body lawfully begoton and for default of such issue it shall remaine to Thome my sone
and to the heires males of hys body and for default of such issue it shall remaine to my other
sones as it before wher sover of the place in Southwarke called the white horse Also I will that
the pss Edward my sone shall have all my lordys and tenementes rentes and pnces and pnces
that I have in the shire of Wpuchelpe to hym and to hys heires forever Also I will that Robert
my sone shall have all the lordys and tenementes rentes and pnces that I have purchasid of
Henry hall sones Robert dward and John pnteryst in the pssh of Wpuchelpe and Eboraci
to hym and to hys heires males of hys body lawfully begoton and for default of such issue
make the Remaunders thereof to Thome my sone and to the heires males of hys body and for
lack of such issue the Remaunders to my other sones as it before wher sover of my lordys and
tenementes Also I will that Thome my sone shall have immediately after my decease all
my other lordys and tenementes rentes and pnces with all thys appertynng wher sover
they be to hym and to the heires males of hys body lawfully begoton and for default of such
issue it shall remaine to my other sones as it before wher sover of the place in Southwarke called
the white horse Also I will that Robert my sone shall pay to Edward my sone my ptech
into the tyme that the pss Edward have the pss lordys and tenementes to the ptech value
of pte by yee as it before wher sover Also I will that Thome my sone shall pay to John my sone
