BOY ACCIDENTALLY SHOT AND IN PERIL.

Change in the County Officials—County Clerk's Assistants—Weber County Finances—Sportsmen—Brevities.

Yesterday morning the six-year-old son of John Casey was shot through the abdomen, and is in a critical condition. Mr. Casey, who is employed at Kemmerer, was at once telegraphed to and he is expected home today. Not much can be learned of the particulars of the shooting, but it seems that the little boy had a gun and was playing with some companions. They were scuffling, the boy Casey holding the gun in his hands, when it was discharged. The ball entered toward the lower part of the abdomen and ranged upward into the lower and back part of the chest, but has not yet been definitely located.

THE OLD AND THE NEW.

Change in the Officials of the County.

The usual biennial change took place at the county courthouse yesterday. The old officers held their places until noon, when the new officials appeared and without any ceremony whatever the various offices were turned over, each to its own new occupant. In the Treasurer's office County Treasurer Chambers turned the office over to himself, revised positions in his chart and the new Treasurer setted himself to perform the duties of the office which his predecessor had performed so satisfactorily to the people during the preceding two years.

In all the other offices new men took their places and now strange faces are seen which will soon become familiar to the public doing business at the courthouse.

Of the retiring officers it may be said that they were capable men in office, and that they discharged the duties of their respective positions in a manner creditable to themselves and their constituents. Those who have done business at the county courthouse during the past two years know and appreciate the capability and integrity of the outgoing officials.

The new officials are particularly capable men whose reputation is such that the people are assured of an honest, capable and economical administration of county affairs. They enter upon the discharge of their duties with the confidence of the people and with the prospect of a pleasant two years' service.

The old Board of County Commissioners met yesterday morning and took up a small amount of business.

The salary of the old county officials was allowed for the two days in January, 1893.

The annual reports from those officials who had not previously reported were filed.

Commissioner Seaman reported that as the auditing committee of the board he had inspected the business of each office and had found everything in first-class condition.

The annual report of County Clerk and Auditor Farr was read and filed, the principal figures of which in recapitulation are shown in another place.

The matter of whether the charge made by Clerk Farr for his services as referee in a certain county matter was a county fee or belonged to Mr. Farr, individually, was referred to the County Attorney.

The minutes of the meeting were read and approved and the board at noon adjourned sine die.

Immediately upon the adjournment of the old board, the new County Commissioners met and organized by electing Commissioner L. R. Adams chairman.

An order of business was adopted similar to the one used by the former board.

Commissioner Adams was made the Committee on Poor and Supplies; Commissioner Smith the Committee on Tax Matters and Commissioner Skeen the Committee on Poor Farm.

The division of the county into commissioners road districts was deferred until the next meeting.

Then came the interesting part of the proceedings, the confirmation of deputies for the various offices. County Clerk Hollingsworth led off and presented the names of his deputies in the following communication:

To the Honorable Board of County Commissioners, Weber County, Utah—Gentlemen—I beg leave to inform you that I have this day appointed the following-named deputies and assistants in the County Clerk's office, to wit: L. J. Holther and L. P. Cahan, deputies, and Miss Eloise Child stenographer and copyist. I will, at your next meeting, advise you of the appointment of another deputy.

The clerical force in the Clerk's office will, therefore, consist of three deputies and one assistant. In this connection I desire to say that this is a reduction of one deputy and one copyist from the present force. But if, at any time, I find that I have insufficient assistance to properly transact the business of the Clerk's office I will so advise this board. Respectfully,

County Recorder Hendersholt named Mrs. E. C. West and David Mattson as his deputies, and they were confirmed.

The matter of salaries for the deputies was left over until another meeting, and the board took a recess until this morning at 10:30 o'clock.
